We're pleased to announce a new British Council initiative.

Further to the wide academic support we offer, all candidates that register for the **B2 First (for Schools) & C2 Proficiency** session and do not receive a pass grade, will be entitled to retake their exam in the next examination session with a 20% discount on the official exam fees of the specific session.

This discount is part of the British Council's policy to ensure that all B2 & C2 test takers are given the opportunity for a second chance to succeed, without burdening their families with the full cost of the exams for a second time.

The following conditions apply:

1. It applies only to
 - a. Test takers from the December 2022 B2 First (for Schools) and/or C2 Proficiency who did not succeed in their exams and wish to retake the test in May-June 2023.
 - b. Test takers from the May-June 2023 B2 First (for Schools) and/or C2 Proficiency who did not succeed in their exams and wish to retake the test in December 2023.
2. It applies only to B2 First (for Schools) test takers who receive total score 159 and below (Cambridge English Scale) and wish to re-sit the exam in the next exam session.
3. It applies only to C2 Proficiency test takers who receive total score 199 and below (Cambridge English Scale) and wish to re-sit the exam in the next exam session.
4. It does not apply to test takers who pass their exams for B2 First (for Schools) or C2 Proficiency and would like to improve their score in the next available session.
5. It does not apply to test takers who register for B2 First (for Schools) or C2 Proficiency but do not participate in these examinations or are absent in one or more components of the exam.
6. It does not apply to those test takers who register for the May 2023 B2 First (for Schools) or C2 Proficiency and wish to re-sit in the June 2023 B2 First (for Schools) or C2 Proficiency. It only applies for the December 2023 exam session, after results become available (evidence of failed results).
7. It applies to both paper-based and computer-based B2 First (for Schools) and/or C2 Proficiency test takers (where sessions are available). In case test takers prefer a computer-based exam but the next available computer-based exams session is cancelled, test takers will be transferred automatically to the next available paper-based exams.
8. The offer applies only to the test takers who took part in the December 2022 or May-June 2023 exams sessions; it is not transferable to other test takers.
9. The British Council reserves the right to amend the Terms and Conditions of this offer and extend it beyond the current scope, following a written notification on the British Council Website.
